This offer will **absolutely** expire on December 15<sup>th</sup>, when regular rates go into effect.

Please note the following with respect to this offer:

- ❖ You must submit a \$500 deposit for each child.
- ❖ The sibling discount for 2<sup>nd</sup> child is \$100.00, 3<sup>rd</sup> child is \$200.00. Temple member discounts are \$25.00 off per week.
- ❖ There will be an additional fee of \$35.00 for security.
- ❖ One overnight, for Sports Academy & Tweens and two overnights for CITs, will be included in the rate. The Club Getaway overnight trip for Sports Academy and Tween campers will require an extra charge.
- ❖ 9<sup>th</sup> and 10<sup>th</sup> graders are automatically put into the CIT program.
- ❖ **All payments are fully refundable if request is made by February 1<sup>st</sup>, 2012. After that date, there will be a \$150.00 administration charge for canceling. However, after May 1<sup>st</sup>, 2012, deposits will not be refunded.**
- ❖ **Early bird deposits are not transferable.**

**All completed material and deposits must be returned to the camp office by December 15, 2011 to lock in these rates.**
